### General Conditions & Instructions to Applicants

1. The application is deemed to be complete and considered only on receipt of the hard copy of the application form duly signed by the candidate along with detailed bio-data, a passport size photograph and copies of certificates.
2. The envelope containing the application may be superscribed on top as "Application for the post of Design Engineer".
3. Last date for receipt of application is 23.04.2018.
4. Applications received after the stipulated date will not be considered. TELK will not be responsible for any postal delay/loss in transit in submission of application within the specified time.
5. Only Indian Nationals need to apply.
6. Panel of candidates forwarded by the Regional Professional and Executive Employment Exchange, Ernakulum shall be considered along with the eligible direct applicants.
7. Normal communal reservation norms as recommended by the Employment Exchange concerned will also apply.
8. Age relaxation for SC/ST/OBC candidates is applicable as per usual Government rules.
9. The candidates are advised to ensure while applying that they fulfill the eligibility criteria and other requirements and that the particulars furnished by them are correct in all respects. In case it is detected at any stage of recruitment process that the candidate

- does not fulfill the eligibility criteria and/ or does not comply with other requirements and/or he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature is liable to be rejected.
10. The Minimum qualification stipulated for the posts must be from an Indian University/Institute recognized by AICTE/appropriate statutory authority in India and should be of regular/full time courses.
  11. Where percentage of mark is not awarded by the University and only grades like GPA, CGPA are awarded, the same should be converted to the equivalent percentage of marks as per the following formula. On a 10 point scale CGPA/GPA of 6.5 will be considered as First Class (60%).
  12. TELK reserves the right to change the number of vacancies, and the vacancies notified may not be filled up. Further, TELK reserves the right to restrict/alter/cancel/modify the recruitment process, if the need so arises, without notice or assigning any reason thereof.
  13. Screening of applications will be done with reference to the qualification, age, experience etc.
