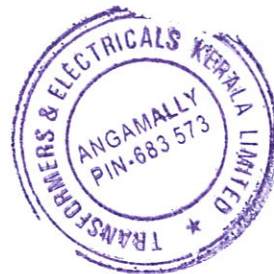

SCOPE OF WORK & GENERAL CONDITIONS OF CONTRACT

Competitive offers are invited for the transportation of Mild Steel Plates & Sections from the stockyard of SAIL, Irimpanam and RINL, Vidakkuzha to our Stores at Angamally for a period of one year.

Detailed scope of work is given below.

1. Materials shall be transported from the stockyard of SAIL/RINL to TELK on the basis of the sale orders from SAIL/RINL from time to time without transshipment enroute.
2. Materials include Mild steel Plates/Sheets, sections of different sizes. Thickness of Plates/Sheets will vary from 3.15mm to 50 mm, Width may be between 1250mm and 2500mm with length 6300mm and up to 12500mm. The length of the sections (Angles/Channels/Rods) is generally 6 meters or 12 meters as the case may be.
3. Rates shall be quoted in the Bill of quantity attached for tonnage of the materials transported. Separate rate may be quoted for Lorry/Trailer loads. Service Tax if applicable may be quoted separately which will be paid extra subject to submission of documentary evidence of remittance.
4. Transportation shall be carried out with responsibility according to the availability of the materials in the stockyard of SAIL/RINL and hence part load shall also be carried out in emergencies.
5. Generally, the validity period of the sale orders from SAIL/RINL are for a limited period only and hence more than one vehicle may be required for transportation of the material in any day in the validity period of the sale orders.
6. Weighment of the materials will be made at the suppliers end as well as after receipt at TELK at weighbridges approved by TELK.
7. Payment of transportation charges will be made only through N.E.F.T. within 45 days of receipt of your bills.
8. Your rates quoted shall hold valid for one year from the date of award of contract and TELK reserves the right to extend the contract for a further period of three months at the same rates and terms & conditions if desired to do so.
9. Rate includes loading/incidental expenses at the loading points but unloading at our end will be arranged by us.
10. Approximate quantity to be transported during the contract period is 900 MTs. depending upon the availability of the material in the stockyard of SAIL/RINL.
11. Your trucks/trailers with material reaching at our premises after 3.00 p.m. will generally be released only on next working day.
12. Halting/detention charges is applicable for overnight detention of the vehicles if your vehicle entered our premises before 2 p.m. on date of invoice.

13. You are solely responsible for the safe and speedy delivery of the materials loaded in your vehicles from SAIL/RINL stockyard to TELK, Angamaly.
14. TELK reserves the right to extend the contract for a further period of six months at the same rates and terms & conditions if desired to do so.
15. TELK reserves the right to terminate the contract, if any of the above terms & conditions are violated or unsatisfactory execution of the contractual terms by the contractor.
16. Your Vehicle shall reach the receiving point(RINL/SAIL stockyard) immediately after release of sale orders which will be intimated to you telephonically or otherwise by our representative.
17. In certain occasions when shortage of Man-Power and / or damage of handling equipments are experienced at our end, unloading of materials may not be possible on the same day. In such circumstances your vehicle will be detained in our premises for which halting charges may be specified in your quotation.
18. The extra costs, if any incurred by us for arranging alternate vehicles due to non-availability of contractor's vehicle will be recoverable from the contractor.
