GENERAL CONDITIONS OF CONTRACT

1. Submission of Tender :

- 1.1 The quotations shall be submitted either in sealed cover or emailed to telktenders@gmail.com so as to deliver before the due date. Quotations emailed to any other email addresses are liable to be rejected.
- 1.2 The tender will be considered FIRM for acceptance for a period of 60 days from the date of opening of the tenders. The bidders will not be free to withdraw or modify their tender within this period, except at the risk of forfeiture to the Company of the Earnest Money deposited if any. If it is found necessary to keep the tender open for a further period, prior consent of the bidder shall be taken in writing for every further period.
- 1.3 The contractor shall submit all tender documents with signature and seal on all pages of the tender documents as a token of its acceptance and all the terms and conditions mentioned therein.

2. Acceptance of Tender :

- 2.1 Tenders submitted incomplete in any respect such as unattested corrections in rates, quantities, units or amounts, figures not expressed in words, totals of contract not entered etc. are liable to rejection.
- 2.2 Tenders which are not in conformity with this tender notice are liable for rejection.
- 2.3 The right to carry out the work either in conformity with or in a manner entirely different from the terms of this invitation that may be considered most suitable before or subsequent to the receipt of tenders due to exigencies, is reserved with the Company.

3. Quality :

The Goods shall be supplied conforming to the description/specifications/samples referred in the order/tender or agreed to upon in writing or otherwise.

4. Terms of payment :

Payment will be made through NEFT within 45 days of receipt and acceptance of material at our Stores, Angamaly unless otherwise specified.

5. Taxes, Levies & Statutory Deductions :

GST if applicable shall be mentioned separately in the quotation and will be paid extra as applicable on producing documentary evidence. Statutory deductions like TDS or as applicable will be deducted from the bills as per Rules.

6. Liquidated Damages:

Liquidated Damages at the rate of 1% per week subject to a maximum of 10% of the order value or as applicable in the Purchase/Work Order will be levied for deliveries beyond the mutually agreed date mentioned in the order.

- 7. Evaluation of the Offers shall be on the basis of "To-Door Cost at TELK, Angamaly" based on NET Cash outflow of TELK.
- 8. The Contractor shall not without the previous written approval of the Company sub contract in respect of any matter touching this contract and the Company shall not be bound by any such sub contract executed by the Contractor without its approval.
- 9. Any further information necessary can be obtained from the office on all working days during office hours.
- For technical qualification we will be evaluating supplier's capability to supply quality material for the entire ordered quantity, past performance references and commercial terms offered.
- 11. In case the lowest bidder (L1) is not a registered / approved supplier of TELK, Angamaly, they will be allowed to supply the items only after evaluation by TELK authorities and enlisting as approved/registered supplier. They shall submit duly filled vendor capability report/supplier registration requisition form available in our website www.telk.com.
- 12. In case L1 is a new supplier to TELK, L2 may also be considered in order to meet urgent requirements.
- 13. TELK has the right to split the order quantities to various parties to meet our delivery commitments.
- **14.** Jurisdiction : Any dispute arising out of this contract will be subject to the jurisdiction of courts having jurisdiction only over the area in which our factory situates.

- 15. Transit insurance for the materials in the scope of supply shall be arranged by the supplier/contractor.
- 16. Right to Accept or Reject the Tenders:
- 16.1 The right to accept the tender in full or in part/parts will rest with TELK.
- 16.2 Tenders not accompanied with prescribed information or are incomplete in any respect, and/or not meeting prescribed conditions, shall be considered as non-responsive and are liable to be rejected.
- 16.3 TELK reserves the right to accept or reject any bid or a part of the bid or to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Buyer's action.
- 16.4 If the bidder gives wrong information in his tender, TELK reserves the right to reject such tender at any stage or to cancel the contract.
- 16.5 Bidder is requested to furnish all the details called for in the tender. In case any required data/information is/are not furnished in the offer, Purchaser reserves the right to assume the same for the purpose of evaluation/comparison and decide the Tender accordingly.

17. SPECIAL CONDITIONS OF SUB-CONTRACT:



- 17.2 The rate quoted shall be exclusive of GST. GST if applicable shall be mentioned separately. Applicable GST will be paid extra on producing documentary evidence.
- 17.3 The rate quoted shall include all charges for transportation, labour, materials and incidental expenses if any for the complete execution of the contract.
- 17.4 The contractor shall compensate to the losses / damages if any caused to the conductors during the execution of the contract.
- 17.5 Necessary cleaning and polishing shall be carried out by the sub-contractor to make the surfaces scratch free smooth.
- 17.6 TELK reserves the right to enhance the quantity by 25% or reduce the order quantity and also to terminate the contract at any time without assigning any reason whatsoever.
- 17.7 TELK reserves the right to inspect / witness the processes and the processed material given for Electro-plating at any point of time at the premises of the Sub-Contractors.
